Explanation of Responses:

- (1) During March 2000, the Company issued additional shares of Class A Common Stock to EchoStar Communications Corporation's 401 (k) Employees' Savings Plan (the "Plan"). The reporting person has dispositive, but no voting power with respect to the shares.

- (5) Each portion of the option expires five years from the date on which that portion of the option first becomes exercisable.
