(1) Represents the number of shares withheld by the issuer to satisfy the tax withholding obligations incurred by the distribution on April 26, 2005 of 150,000 shares of a previously vested, deferred restricted stock grant held by the reporting person the deferral of which expired on April 26, 2005; sales of the remaining 95,325 shares will be restricted until November 11, 2005. In addition, upon the reporting person's voluntary termination of employment with the Company, if the foregoing lock-up period has not yet expired, it shall be extended for an additional five year period. Upon a change in control of the Company, any lock-up release period that is still in effect in respect of such shares upon the occurrence of such change in control shall terminate.

(2) The amount of securities reported as beneficially owned following the reported transaction includes: (i) 11,170 shares of restricted stock 3,723 shares of which will vest on each of January 1, 2006 and 2007, and 3,724 shares of which will vest on January 1, 2008; and (ii) 6,921 shares of restricted stock which vests on February 9, 2007, in each case subject to acceleration under certain circumstances.
