The securities of the Company were acquired by Mr. Gibbs for investment. Mr. Gibbs reserves the right to acquire additional shares of the Company s common stock, either in open market purchases or in private transactions.
ITEM 5. INTEREST IN SECURITIES OF THE ISSUER
Item No. 5 is hereby amended to read as follows:

At the close of business on July 10, 2012, Mr. Gibbs would be deemed the beneficial owner, within the meaning

of Rule 13d-3 under the Exchange Act, of an aggregate of 35,678,950 shares, consisting of 35,162,450 shares owned individually, 466,500 shares owned by Tri Power Resources, Inc. and 50,000 shares owned by Redwood MicroCap

Fund, Inc, both corporations controlled by Mr. Gibbs. The securities represent 75.11% of the issued and outstanding shares of common stock of the Company. The foregoing is based upon 47,500,000 shares of common stock issued and outstanding as of the date of this report.

- (b) Mr. Gibbs has the sole voting and dispositive power with respect to all of the shares of common stock identified in Item 5(a) above, except as noted.
- (c) Mr. Gibbs has not purchased or sold any shares of common stock during the past 60 days, except as disclosed herein.
