The Reporting Person indirectly owns 883,794 shares of NIC common stock, which are held directly by the National Information Consortium Voting Trust ("Voting Trust"), for which Messrs. Jeffery S. Fraser and Ross C. Hartley act as trustees, for the benefit of the Reporting Person as a direct beneficiary of the Voting Trust.

The Reporting Person also directly owns employee stock options to purchase 16,225 shares of NIC common stock at \$3.04 per share, of which 3,725 are currently exercisable and 12,500 will become exercisable on August 1, 2007. The Reporting Person also indirectly owns 1,500 shares of NIC common stock which are held directly by the Reporting Person's spouse.
