Explanation of Responses:

1. Represents the value of the Reporting Person's Company Stock Fund Account in the Company's 401(k) plan as of September 15, 2002, expressed as share equivalents. As of such date, approximately 96.91% of such fund was invested in Company Common Stock, and the remainder was invested in cash.
2. Represents shares of restricted stock granted to the Reporting Person on October 8, 1996 under the Issuer's Long Term Stock Incentive Plan that may vest over the next three years.
3. Represents the value of the Reporting Person's Company Stock Fund Account in the Company's Supplemental Savings and Investment Plan as of September 15, 2002, expressed as share equivalents. As of such date, approximately 96.98% of such fund was invested in Company Common Stock, and the remainder was invested in cash. Please note that share equivalent accounting affects the total in column 5.
4. Reflects shares allocated to the Reporting Person's account under the Company's Salary and Bonus Deferral Plan.
5. Represents an option granted to the Reporting Person on May 18, 2001 under the Issuer's Omnibus Incentive Compensation Plan to purchase 18,000 shares of the Issuer's Common Stock at \$16.87 per share.
6. Represents an option granted to the Reporting Person on January 24, 2002
