AWM also serves as the general partner of MGP Advisers Limited Partnership (MGP), the general partner of and investment adviser to Special Situations Fund III, L.P. (SSF3) and general partner of Special Situations Fund III QP, L.P. (SSFQP). Marx and Greenhouse are also members of SST Advisers, L.L.C. (SSTA), the general partner of Special Situations Technology Fund, L.P. (Technology) and the Special Situations Technology Fund II, L.P. (Tech II). AWM serves as the investment adviser to SSFQP, Technology and Tech II. (SSF3, SSFQP, Cayman, Technology and Tech II will hereafter be referred to as, the Funds). The

principal business of the Funds is to invest in equity and equity-related securities and other securities of any kind or nature.
