In accordance with the 1997 Stock Option and Compensation Plan and the Issuer's policies concerning option grants to outside Directors, (1) on February 21, 2006, Mr. Wade received a grant of options to purchase 2,500 shares with a two year term, 500 of which become exercisable for each meeting of the Board of Directors attended by Mr. Wade as an outside director.

(2) Acquired pursuant to the Issuer's 1997 Stock Option and Compensation Plan in lieu of Mr. Wade's outside Director's Meeting Fee of \$4,000 for the meetings of the Board of Directors for the quarter ended March 31, 2007. The amount of shares was determined according to the closing price of the Common Stock on March 30, 2007.

(3) All amounts of securities beneficially owned, options and option exercise prices have been adjusted for the 1-for-50 reverse stock split effective February 12, 2007.
