The cumulative number of phantom units held by the director has been adjusted, in accordance with the terms of the Phantom Plan, to reflect the split in phantom units effected in connection with, and as a consequence of, the June 1, 2006 stock split in the form of a 100% stock dividend of the Company's common stock.
