- (1) The common stock was acquired as a result of the vesting of restricted stock units.
- (2) Each restricted stock unit represents a contingent right to receive one share of Common Stock. The Reporting Person receives one share of Common Stock for each restricted stock unit that vests.

The reported shares represent the aggregate number of shares held by the Novack Family 1999 Revocable Trust, of which the Reporting Person's minor child is one of four beneficiaries. The Reporting Person disclaims beneficial ownership of the shares of Common Stock held by the Novack Family 1999 Revocable Trust, except to the extent of his minor child's pecuniary interest therein.
- (3) This award of restricted stock units vests in annual increments of 25% beginning on May 1, 2006 through 2009. The vested shares of Common Stock will be issued to the Reporting Person upon vesting.
