Item Entry into a Material Definitive Agreement.

On May 18, 2010, we entered into a Securities Purchase Agreement whereby we agreed to sell one convertible note to one investor for gross proceeds of \$35,000. The convertible note that we agreed to sell has a face amount of \$35,000, is due and payable on February 21, 2011, earns interest at a rate of 8% per annum and is convertible, at the option of the holder, into shares of our common stock at a conversion price as set forth in the convertible note.

Item Unregistered Sales of Equity Securities.

On May 18, 2010, we sold one convertible debenture to one investor for gross proceeds of \$35,000. This convertible debenture has a face amount of \$35,000, is due and payable on February 21, 2011, earns interest at a rate of 8% per annum and is convertible, at the option of the holder, into shares of our common stock at a conversion price as set forth in the convertible note.

The investor is an accredited investor, and in issuing the convertible note we relied on the exemption from the registration requirements of the Securities Act of 1933, as amended (the “Act”), provided by Section 4(2) of the Act and/or by Rule 506 of Regulation D promulgated thereunder.
