On November 21, 2011, Mr. Gregg adopted a 10b5-1 Plan. Under the 10b5-1 Plan, Mr. Gregg will sell a limited number of shares to cover the tax liability that accrues upon monthly vesting of restricted stock units previously granted to Mr. Gregg. The shares set forth above were sold pursuant to the 10b5-1 Plan.

This transaction was executed in multiple trades at prices ranging from \$11.36 to \$11.67. The price above reflects the weighted average sale price. The reporting person hereby undertakes to provide upon request to the SEC staff, the issuer or a security holder of the issuer full information regarding the number of shares and prices at which the transactions were effected.

Included in this number are 32,500 unvested restricted stock units granted on March 12, 2010, 4,062 of which shall vest each month through March 12, 2013; 101,563 unvested restricted stock units granted on March 8, 2011, 5,078 of which shall vest each month through March 8, 2014; and 162,501 unvested restricted stock units granted on March 8, 2012, 5,078 of which shall vest each month through March 8, 2015.
