company, announced that the Indiana Utility Regulatory Commission approved the natural gas distribution base rate increase for its wholly owned subsidiary, Indiana Gas Company, Inc. which does business as Vectren Energy Delivery of Indiana-North (Vectren North). Vectren North will implement the new distribution rates as of December 1. A copy of the press release is furnished as Exhibit 99-1 to this Current Report.
