- (1) 130,000 Restricted Stock Equivalents converted into the same number of shares of Energizer Common Stock upon Reporting Person's retirement as an officer, and converted shares were issued to him.
  - (2) Phantom stock units were paid out in cash following termination of Reporting Person's employment with Energizer Holdings, Inc., in accordance with the terms of the benefit plans involved.  
  
The grant of restricted stock equivalents was issued as consideration for Reporting Person's covenant not to compete with the issuer for a period of 5 years following his retirement as chief executive officer. The award will vest and convert into shares of Energizer Common
  - (3) Stock on January 25, 2010, but will be forfeited if, prior to that date, the Reporting Person engages in conduct which is in violation of the covenant not to compete. The award will, however, immediately vest upon the death or disability of the Reporting Person, and upon a change in control of the issuer.
  - (4) Restricted Stock Equivalent will vest and convert into Energizer Holdings, Inc. common stock on January 25, 2010.
