### Amendment No. 39 to Statement on Schedule 13D

This amended statement on Schedule 13D relates to the Common Stock, \$.001 par value per share (the "Shares"), of First Financial Fund, Inc., a Maryland corporation (the "Company"). Items 4 and 5 of this statement, previously filed by the Ernest Horejsi Trust No. 1B (the "Trust"), the Lola Brown Trust No. 1B (the "Brown Trust"), the Mildred B. Horejsi Trust (the "Mildred Trust"), the Stewart R. Horejsi Trust No. 2 (the "Stewart Trust"), and the Susan L. Ciciora Trust (the "Susan Trust") as the direct beneficial owner of Shares, and Badlands Trust Company LLC ("Badlands LLC") and Stewart R. Horejsi, by virtue of the relationships described previously in this statement, are hereby amended as set forth below.

#### Item 4. Purpose of Transaction.

No change except for the addition of the following:

The Trust sold 78,500 Shares as described in Item 5(c) of this statement in order to reduce its equity interest in the Company and to generate cash flow to pay current and future obligations. The Reporting Persons previously indicated a present intention to liquidate up to 900,000 Shares over a 12 month time period, subject to limitations imposed by Rule 144 of the Securities Act of 1933. In furtherance thereof, the Reporting Persons filed Forms 144 with the Securities and Exchange Commission on November 3, 2004, May 25, 2005, August 24, 2005, and November 22, 2005, and an Amended Form 144 on January 9, 2006, giving notice of the proposed sales.

The Trust, the Brown Trust, the Mildred Trust, the Stewart Trust, and the Susan Trust received the 2,412,546 Shares listed in Item 5(c) of this statement as a result of the Company's December 30, 2005 stock dividend. On November 22, 2005, the Company announced that its Board of Directors declared a common stock dividend of \$4.12 per Share payable on December 30, 2005, to holders of record as of December 7, 2005. The Board of Directors further declared that the dividend would be paid in stock unless shareholders made an affirmative election to receive cash. The Trust, the Brown Trust, the Mildred Trust, the Stewart Trust, and the Susan Trust all received the dividend in the form of stock. The Shares were issued on December 30, 2005 at the Company's net asset value as of that date of \$14.83 per Share. The Shares were posted to the Trust, the Brown Trust, the Mildred Trust, the Stewart Trust, and the Susan Trust's accounts on January 4, 2006.

Depending upon their evaluation of the Company's investments and prospects, and upon future developments (including, but not limited to, performance of the Shares in the market, the effective yield on the Shares, availability of funds, alternative uses of funds, and money, stock market and general economic conditions), any of the Reporting Persons or other entities that may be deemed to be affiliated with the Reporting Persons may from time to time purchase Shares, and any of the Reporting Persons or other entities that may be deemed to

be affiliated with the Reporting Persons may from time to time dispose of all or a portion of the Shares held by such person, or cease buying or selling Shares. Any such additional purchases or sales of the Shares may be in open market or privately-negotiated transactions or otherwise.

### Item 5. Interest in Securities of the Issuer.

No change except for the addition of the following:

(a) The Trust is the direct beneficial owner of 1,720,406 Shares, or approximately 6.13% of the 28,061,941 Shares outstanding as of January 6, 2006, according to information contained in the Company's press release (the "Outstanding Shares"). The Brown Trust is the direct beneficial owner of 3,000,693 Shares, or approximately 10.69% of the Outstanding Shares. The Mildred Trust is the direct beneficial owner of 2,456,472 Shares, or approximately 8.75% of the Outstanding Shares. The Stewart Trust is the direct beneficial owner of 2,169,602 Shares, or approximately 7.73% of the Outstanding Shares. The Susan Trust is the direct beneficial owner of 1,737,573 Shares, or approximately 6.19% of the Outstanding Shares.

By virtue of the relationships reported in this statement, Mr. Horejsi may be deemed to share indirect beneficial ownership of the Shares directly beneficially owned by the Trust, the Brown Trust, the Mildred Trust, the Stewart Trust and the Susan Trust. Mr. Horejsi disclaims all such beneficial ownership.
