Pursuant to the terms of the warrant previously disclosed on a Form 4 filed February 2, 2007, as a result of certain anti-dilution provisions (2) being triggered on June 25, 2008, the number of common shares underlying the Reporting Person's warrant increased from 1,000,000 to 1,455,157 and the exercise price decreased from \$0.32 per share to \$0.22 per share.
