(a) Amount beneficially owned:

As of December 31, 2012, Corstar Holdings, Inc. held 3,734,567 shares of CorVel stock.(1) As of December 31, 2012 Jeffrey J. Michael individually owned 91,250 shares of CorVel stock and options of 21,750 exercisable within 60 days of December 31, 2012. Mr. Michael is the President and CEO and the sole director of Corstar Holdings, Inc. Mr. Michael disclaims beneficial ownership of shares held by Corstar Holdings, Inc. except to the extent of his pecuniary interest therein.

(b) Percent of class:

Based on 11,211,289 shares of the Issuer's common stock outstanding as of October 30, 2012 as reported in the Issuer's Form 10-Q for the quarterly period ended September 30, 2012: Corstar Holdings, Inc. may be deemed to the beneficial owner of 33.31% of the Issuer's common stock and Mr. Michael may be deemed to be the beneficial owner of 34.32% of the Issuer's common stock.

(c) The Reporting Persons have the power to vote or dispose of the number of shares as follows:

(i) Sole power to vote or to direct the vote.

Mr. Michael may be deemed to have the sole power to vote or direct the vote of 113,000 shares of common stock based on his ownership of 91,250 shares and options to purchase 21,750 shares that are exercisable within 60 days of December 31, 2012.

(ii) Shared power to vote or to direct the vote.

Mr. Michael and Corstar Holdings, Inc. maybe deemed to share the power to vote or direct the vote with respect to 3,847,567 shares of common stock.

(iii) Sole power to dispose or to direct the disposition of.

Mr. Michael has sole power to dispose or control the disposition of 113,000 shares of common stock based on his ownership of 91,250 shares and options to purchase 21,750 shares that are exercisable within 60 days of December 31, 2012.

(iv) Shared power to dispose or to direct the disposition of.

Mr. Michael and Corstar Holdings, Inc. maybe deemed to have shared power to dispose of or shared power to direct the disposition of 3,847,567 shares of common stock.
