On November 21, 2013, Dynegy Inc. ( Dynegy ) issued a press release announcing that the Illinois Pollution Control Board granted a variance to Illinois Power Holdings, LLC, a Dynegy wholly-owned subsidiary, Ameren Energy Resources Company, LLC and AmerenEnergy Medina Valley Cogen, LLC for temporary relief from the SO<sub>2</sub> portion of the Illinois Multi-Pollutant Standard air emissions rule.
