The deferred stock units are fully vested and will be settled in shares of the Company's common stock either (i) on a date selected by the reporting person pursuant to the Company's Management Deferred Stock Unit Purchase Plan, as amended (the "Plan"), or (ii) as otherwise provided by the Plan.

(3) Each restricted stock unit represents the right to receive one share of common stock of the Company.

(4) The restricted stock units vest and will be settled in shares of the Company's common stock on the three-year anniversary of the grant date, subject to vesting acceleration pursuant to the Plan.
