As of December 31, 2007, Mr. Lamonde beneficially owns an aggregate of 36,643,000 Multiple Voting Shares which represent approximately 91.89% of the voting power in EXFO and 53.12% of the issued and outstanding shares of EXFO, being 36,643,000 Multiple Voting Shares and 32,334,679 Subordinate Voting Shares. Mr. Lamonde has the sole power to vote or direct the vote of 36,643,000 Multiple Voting Shares and the sole power to dispose or direct the disposition of 36,643,000 Multiple Voting Shares. Of the 36,643,000 Multiple Voting Shares beneficially owned by Mr. Lamonde, 34,743,000 Multiple Voting Shares are held of record by GLIF and 1,900,000 Multiple Voting Shares are held of record by FGL. GLIF is controlled by Mr. Lamonde, and the FGL is a family trust for the benefit of Mr. Lamonde and members of his family.
