## Company interest in the Petrochemical Sector

---

(Rio de Janeiro, January 08, 2004). PETRÓLEO BRASILEIRO S/A - PETROBRAS, [Bovespa: PETR3/PETR4, NYSE: PBR/PBRA, Latibex: XPBR/XPBRA], a Brazilian international energy company, announces that with respect to various reports in the press today, it is currently reviewing its strategic planning, which will consider a reformulation of its position in relation to the domestic petrochemical industry.

As part of this process and in line with its normal activities, which include the identification of new investment opportunities in the petrochemical sector as well as others in which it is active in Brazil and internationally, the Company has been in discussions with various petrochemical companies through its Petrobras Química S.A. Petroquisa subsidiary. These discussions have resulted in exchanges of correspondence indicative of a preliminary, but non-binding, interest in the parties concerned. In relation to IPQ, such contacts have not resulted in any commitment to continue such exchanges, there being no negotiations in progress involving the latter company, or its controlling shareholders.

As part of its disclosure policy, Petrobras will make an announcement to the market as to any decision committing the Company to a new acquisition in either the domestic or the international market.
