## **CVRD's proposed acquisition of Caemi cleared**

Rio de Janeiro, July 18, 2003 - Companhia Vale do Rio (CVRD) informs that the European Commission approved its proposal to acquire the sole control of Caemi Mineração e Metalurgia S.A. (Caemi). After the conclusion of this transaction, CVRD will own 100% of Caemi's common shares and 40% of its preferred shares, totaling 60.2% of Caemi's total capital.
