("Empire Capital"), with respect to the 3,267,899 shares, Empire Capital Partners, Ltd. a Cayman Islands exempted company ("Offshore") as to 2,943,553 shares, Empire Capital Partners II, Ltd., a Cayman Islands exempted company ("Offshore II") as to 552,601 shares, Charter Oak Partners, LP a Delaware Limited Partnership ("Charter Oak") as to 982,015 shares and Charter Oak Partners II ("Charter Oak II") and collectively with Empire Capital, Offshore, Offshore II, and Charter Oak, "the Empire Funds") as to 125,532 shares of Common Stock directly owned by it.
