- (1) Each restricted stock unit represents a contingent right to receive one share of Emcore common stock. Restricted stock units are payable, at the election of the issuer, in cash, Emcore common stock, or a combination of the two.  
  
The restricted stock units vest in three equal annual installments beginning on August 22, 2012. Vested shares of Emcore common stock,
- (2) an amount in cash equal to their fair market value or a combination of both will be delivered to the reporting person not later than 30 days after vesting occurs.
- (3) The restricted stock units were awarded to the reporting person for no cash or other similar consideration.
- (4) On August 24, 2011, the reporting person filed a Form 4 reporting an annual grant of 90,000 restricted stock units to the reporting person under the Company's 2010 Equity Incentive Plan in Table I instead of Table II.
- (5) Subsequent to the filing of the reporting person's original Form 4, 40,000 of the 90,000 restricted stock units originally granted were canceled for no value.
