On December 13, 2013, the reporting person contributed 40,000 shares of AMETEK Common Stock to Klein Charitable Remainder Unitrust, a charitable remainder trust of which the reporting person and his spouse are two of the co-trustees and of which his wife is a beneficiary. The reporting person continues to report beneficial ownership of all of the AMETEK Common Stock held by the trust but disclaims beneficial ownership except to the extent of his wife's pecuniary interest therein.
- (1) Distribution of shares by the trust in accordance with the terms of the trust. Mr. Klein disclaims beneficial ownership of all shares held by the trust.
- (3) The stock options will become exercisable in four equal annual installments beginning on April 23, 2009.

- (6) The stock options will become exercisable in four equal installments beginning on May 3, 2012.

- (8) The stock options will become exercisable in four equal annual installments beginning on July 26, 2013.
- (9) The stock options will become exercisable in four equal annual installments beginning on May 8, 2014.
