(2) Each restricted stock unit ("RSU") has the economic equivalent of one share of CIT common stock.

Performance Based Restricted Stock Units ("PBRUSU") are scheduled to settle 100% in stock and will vest one-third per year on March 1, (3) 2020, 2021, and 2022, subject to a performance based vesting hurdle (minimum Common Equity Tier 1 for well-capitalized Banks as established by the Federal Reserve Board).
