This process was delayed on account of the fact that the Registrant's previous auditor was recently acquired by another accounting firm, which caused some transitional delays, as well as the fact that the audit partner formerly responsible for overseeing the review of the Registrant's filings was rotated off the engagement in compliance with rotation requirements promulgated by the Public Company Accounting Oversight Board. As a result, the Registrant is unable to file its Form 10-Q on the prescribed due date without unreasonable effort or expense.
