(1) The shares will be held in a trust established for the benefit of Mr. Forrest until July 2010.

(2) Each DRSU is the economic equivalent of one share of Minerals Technologies Inc. Common Stock.

(3) Mr. Forrest has 2,830 shares of Minerals Technologies Inc. Common Stock under the Company's 401(k) Plan. The information in this report is based on a Plan Statement dated as of December 31, 2009.

(4) Mr. Forrest was granted 2,400 DRSUs on February 23, 2005 which were scheduled to vest on February 23, 2010. Upon Mr. Forrest's retirement on December 31, 2009, 1,920 DRSUs vested (representing the prorated number of shares based on full years of service from the grant date) pursuant to the terms of the subject grant. The remaining DRSUs for which vesting was not accelerated were forfeited by Mr. Forrest upon his retirement.
