On April 15, 2010 the board of directors made an award of 36,000 shares of restricted stock to Mr. Beury. The award vests over three (3) years, with 33% of the grant vesting on the first anniversary of the grant date and in quarterly increments of 8.3% thereafter. An additional 20% of the base grant may be awarded on the anniversary of each grant if certain performance goals are met, such that Mr. Beury may ultimately receive up to 57,600 shares if all of the performance goals are met.
