(1) The disposition of shares occurred pursuant to an Purchase and Exchange Agreement among the Issuer and Banc of America Preferred Funding Corporation ("PFC") pursuant to which PFC exchanged 2,650 existing Variable Rate MuniFund Term Preferred Shares of NAD for an equal number of newly issued Variable Rate MuniFund Term Preferred Shares, Series 2019, of NAD, and purchased 720 newly issued Variable Rate MuniFund Term Preferred Shares, Series 2019, of NAD, for a purchase price of \$100,000 per share.

(2) This statement is jointly filed by Bank of America Corporation and PFC. Bank of America Corporation holds an indirect interest in the securities listed in Table I (the "Securities") by virtue of its indirect ownership of its subsidiary PFC.
