Item 1. Security and Issuer

This Statement on Schedule 13D (this "Statement") relates to the ownership of auction rate preferred shares ("ARPS") of The Putnam Municipal Opportunities Trust (the "Issuer"). This Amendment is being filed by the Reporting Persons (as defined below) as a result of the repurchase and retirement of the Issuer's ARPS by the Issuer that caused the Reporting Persons ownership to increase. The Issuer's principal executive offices are located at One Post Office Square, Boston, MA 02109.

All series of ARPS issued by the Issuer that vote together as a single class are treated as one class.

Item 2. Identity and Background

(a) This Statement is being filed on behalf of each of the following persons (collectively, the "Reporting Persons"):

- i. Bank of America Corporation ("BAC")
- ii. Bank of America, N.A. ("BANA")
- ii. Blue Ridge Investments, L.L.C. ("Blue Ridge")
- iii. Merrill Lynch Fenner & Smith Incorporation ("Merrill Lynch")

This Statement relates to the ARPS that are held for the accounts of BANA, Blue Ridge, and Merrill Lynch

(c) BAC, through its wholly-owned subsidiaries, BANA, Merrill Lynch and Blue Ridge, is engaged in providing a diverse range of financial services and products. Since settlements with the Securities and Exchange Commission and certain state agencies in 2008, Merrill Lynch and certain predecessors have worked with their customers and issuers of auction rate preferred securities to provide liquidity to the auction rate preferred securities market. This has included purchasing auction rate preferred securities from their customers and working with issuers so that they are able to redeem outstanding auction rate preferred securities. BAC's efforts to work with issuers continue and may include working with the Issuer in the future.

- (d) Other than as set forth on Schedule II, during the last five years, none of the Reporting Persons, and to the best knowledge of the Reporting Persons, none of the Listed Persons, have been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors) or was a party to a civil proceeding of a judicial or administrative body of competent jurisdiction as a result of which such person was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws, or finding any violation with respect to such laws.

The Reporting Persons declare that neither the filing of this Statement nor anything herein shall be construed as an admission that such person is, for the purposes of Section 13(d) of the Exchange Act or any other purpose, (i) acting (or has agreed or is agreeing to act together with any other person) as a partnership, limited partnership, syndicate, or other group for the purpose of acquiring, holding or disposing of securities of the Company or otherwise with respect to the Company or any securities of the Company or (ii) a member of any group with respect to the Company or any securities of the Company.

On August 23, 2017, the Reporting Persons percentage ownership of the Issuer's ARPS increased as a result of ARPS repurchased and retired by the Issuer.
