Item 2.02 Results of Operations and Financial Condition.

On May 17, 2010, Deer Consumer Products, Inc. (the “Company”) issued a press release announcing the Company has raised its 2010 earnings guidance to approximately \$26 million in net income on revenues of approximately \$160 million. A copy of the press release is attached as Exhibit 99.1 hereto and is incorporated by reference.

Item 8.01. Other Events.

On May 17, 2010, the Company issued a press release announcing that the Board of Directors of the Company has authorized a stock repurchase program under which the Company may repurchase up to \$20,000,000 of its outstanding common stock, par value \$0.001 per share, from time to time commencing on May 17, 2010 (the “Repurchase Program”). Under the Repurchase Program, the Company may from time to time, at management’s discretion, make one or more purchases on the open market. Any common stock repurchased by the Company will become part of its treasury stock and retained for possible future uses.
