**Item 5.07 Submission of Matters to a Vote of Security Holders.**

On June 5, 2013, we held our annual meeting of stockholders. A total of 30,232,949 shares were represented in person or by proxy at the meeting. Our stockholders considered three proposals as described in our proxy statement filed on April 15, 2013. The final results of the voting on each matter submitted to our stockholders at the annual meeting are set forth below.

**Proposal 1 – Election of Class I Directors.** The stockholders elected the nominees for Class I director by the vote shown below.
