On December 7, 2012, the reporting person was granted 25,880 Restricted Share Units ("RSUs") vesting in two installments; 12,940

(1) RSUs vesting on December 7, 2013 and 12,940 RSUs vesting on December 7, 2014. Subsequently, the Compensation Committee made the determinations to satisfy the RSU award by delivering common shares rather than cash.

(2) Each RSU entitles the holder to receive delivery of one common share upon satisfaction of RSU vesting period.

(3) The common shares are priced in US dollars.
