This Amendment No. 1 to Statement of Beneficial Ownership on Schedule 13D (this “Amendment No. 1”) amends the Statement of Beneficial Ownership on Schedule 13D filed by the Reporting Persons on December 10, 2014 (the “Schedule 13D” or this “Statement”), with respect to to the Common Stock, par value \$.001 per share (the “Common Stock”), of ARI Network Services, Inc., a Wisconsin corporation (the “Company”). Capitalized terms used but not defined in this Amendment No. 1 shall have the meanings set forth in the Schedule 13D. Except as amended and supplemented by this Amendment No. 1, the Schedule 13D remains unchanged.

**Item 4. Purpose of Transaction.**

On September 14, 2015, Park City Capital, LLC sent a letter to the Company, which is attached as Exhibit 99.1 hereto.

**Item 5. Interest in Securities of the Issuer.**

(a) The Reporting Persons beneficially own in the aggregate 1,000,000 shares of Common Stock, which represents approximately 5.9% of the Company’s outstanding shares of Common Stock. The Master Fund directly holds, and has the shared power to direct the voting and disposition of, the number and percentage of shares of Common Stock disclosed as beneficially owned by it in the applicable table set forth on the cover page to this Statement. None of the other Reporting Persons directly hold any of the shares of Common Stock disclosed in this Statement.

The percentage ownership of shares of Common Stock set forth in this Statement is based on 16,909,055 shares of Common Stock issued and outstanding as of June 9, 2015, as reported in the Company’s Quarterly Report on Form 10-Q filed with the SEC on June 15, 2015.
