deemed to be the beneficial owner of 721,316 Units, which constitutes approximately 38.7% of the outstanding Units.

CRANDALL

Because of his positions as President and sole stockholder of Algenpar, one of two general partners of Alpine, Crandall may, pursuant to Rule 13d-3 of the Act, be deemed to be the beneficial owner of 721,316 Units, which constitutes approximately 38.7% of the outstanding Units.

FOUNDATION

Foundation is not the beneficial owner of any Units.
