No one such other person's interest in the securities whose ownership is reported here relates to more than five percent of the class.

OrbiMed Advisors LLC and OrbiMed Capital LLC hold shares on behalf of Caduceus Capital Master Fund Limited (326,900 shares), Caduceus Capital II, L.P. (321,000 shares), UBS Eucalyptus Fund, LLC (247,300 shares), PW Eucalyptus Fund, Ltd. (21,500 shares), Summer Street Life Sciences Hedge Fund Investors LLC (91,000 shares), Knightsbridge Post Venture IV L.P. (16,400 shares), Knightsbridge Netherlands II, L.P. (6,300), Knightsbridge Netherlands III - LP (11,000 shares), Knightsbridge Venture Capital VI, L.P. (21,300 shares), Biotech Growth Trust plc (173,900 shares), and Stichting Pensioenfonds ABP (263,400 shares).

The reporting persons are a party to certain cash settled over the counter swap agreements which synthetically provides additional long exposure to the Issuer, and as a result, the reporting persons are entitled to the economic benefits, and are subject to the economic risks, of owning the Common Stock, but have no rights, powers, agreements, arrangements or understandings with respect to any shares of Common Stock as a result of those agreements. Neither the control person or any of its affiliates is the beneficial owner of shares of Common Stock as a result of the swap agreements described above, and, accordingly, the number of shares of Common Stock stated as beneficially owned by the Reporting Persons in this Schedule 13G does not include any ownership as a result of such swap agreements.
