The Units are generally redeemable for cash equal to the contemporaneous market price of shares of beneficial interest in the issuer or, at the election of the issuer, for a like number of shares of beneficial interest in the issuer, without payment of any conversion or exercise price. These derivative securities are currently redeemable, except that 19 Units are redeemable beginning 9/15/2011. The Units have no expiration date.
- (1) The reporting person's spouse made a gift of Units to a 2011 GRAT for the benefit of the reporting person's spouse. The reporting person is the trustee of this GRAT.
