- (1) These Stock Fund Units were acquired under the Executive Deferred Compensation Plan (EDCP) and convert to stock on a one-for-one basis.

- (3) The price of derivative securities was inadvertently reported as \$65.88 in the Form 4 filed on February 4, 2008. The correct price is \$56.88.
- (4) The Reporting Person effected an intra-plan transfer of funds held in other investment options under the EDCP to the Company Stock Fund under the EDCP. The transaction was a discretionary transaction exempt under 16b-3(f). The transaction resulted in an acquisition of 3,853.35 units in the Stock Fund at \$56.88 per unit.
