 - (1) Represents 17,325 shares of restricted common stock, \$0.0001 par value per share, awarded pursuant to the Company's 2004 Stock Incentive Plan, as amended, and subject to a restricted stock agreement to be entered into between the Company and Mr. Brugger. Pursuant to the restricted stock agreement, 25% of the shares of restricted Common Stock shall vest on February 25, 2010 and an additional 6.25% of the shares of restricted Common Stock shall vest at the end of each three-month period thereafter.
 - (2) Represents an option granted by the issuer pursuant to the issuer's 2004 Stock Incentive Plan. Subject to certain criteria, the shares subject to such option vest as to 6.25% of the shares at the end of each three-month period following the grant date
