Effective January 1, 2012, the Reporting Person, Mr. David DiStaso, acquired 7,500 shares of iStar common stock upon the vesting of Restricted Stock Units (Units) pursuant to an award originally dated December 19, 2008, as amended July 1, 2011. After deducting 3,020

(1) shares for applicable tax withholding, the Reporting Person acquired a net amount of 4,480 shares of iStar common stock. Following the transactions reported in this Form 4, the Reporting Person is the beneficial owner of a total of 5,653 shares of iStar common stock, which are owned directly.

(2) The Reporting Person is also the owner of 43,919 Units representing the right to receive an equivalent number of shares of iStar common stock (net of shares deducted for taxes and other withholdings) if and when the Units vest.
