- (1) Purchased Common Stock shares as part of the Company's Long-Term Retention Plan. The Plan provides certain management employees the opportunity to purchase Company stock with a defined portion of their annual incentive compensation at a discount to the market price. For 2012, purchases were made at a 25% reduction to the average closing price during December 2011. Shares cannot be sold prior to September 23, 2012.
