(1) The shares acquired represent the vesting and automatic settlement of 8,828 of reporting person's restricted stock units on March 2, 2015.

(2) The shares acquired represent the vesting and automatic settlement of 8,682 of reporting person's restricted stock units on March 2, 2015.

(3) The shares acquired represent the vesting and automatic settlement of 13,684 of reporting person's performance restricted stock units on March 2, 2015.

(4) Each restricted stock unit represents a contingent right to receive one share of Boingo Wireless, Inc. common stock

(5) The restricted stock units will vest with respect to 50% of the restricted stock units on March 1, 2014, and with respect to the balance of the restricted stock units in a series of four successive equal quarterly installments thereafter. The restricted stock units will be settled in shares of common stock that will be delivered to the Reporting Person shortly after each vesting date.

(6) The restricted stock units will vest in a series of twelve successive equal quarterly installments beginning on March 1, 2014, so that the restricted stock units will become fully vested on March 1, 2017. The restricted stock units will be settled in shares of common stock that will be delivered to the Reporting Person shortly after each vesting date.

(7) 1/3 of these performance restricted stock units will vest on March 1, 2015 and the balance will vest in a series of eight successive equal quarterly installments thereafter, so that the performance restricted stock units will become fully vested on March 1, 2017. The performance restricted stock units will be settled in shares of common stock that will be delivered to the Reporting Person shortly after each vesting date
