- (1) The total includes the acquisition of 3,3481 shares at \$46.630 per share received on 10/07/09 through dividends paid in shares.
- (2) There is no reportable change since the last filing. This is a reiteration of holdings only.

(4) As previously reported, on 01/15/09 the Reporting Person was granted 19,690 restricted stock units ("RSUs"), 9,845 of which will vest on each of 01/15/10 and 01/15/11. The 33,8316 dividend equivalent rights being reported reflect 33,8316 dividend equivalent rights at \$45.96 per RSU credited to the Reporting Person's account on 10/07/09.

(5) On 12/10/09 the Reporting Person was granted 18,061 restricted stock units ("RSUs"), 9,030 of which will vest on 12/10/10 and 9,031 of which will vest on 12/10/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP
