(1) This amendment is being filed to include conversions of preferred stock into common stock of the issuer that were erroneously omitted from the original filing. These common shares were omitted from subsequent Forms 4 filed by the reporting person after the original Form 4 was filed.

(2) The reporting person converted 5,821 shares of Series A convertible preferred stock into common stock on September 30, 2005. The preferred stock was convertible into common stock on a one-for-one basis and had no expiration date.

(3) The reporting person is a partner in Clear View Investment Fund, L.P. as well as the sole member of Beach Asset Management, LLC, the general partner of the fund.

(4) The reporting person converted 9,315 shares of Series A convertible preferred stock into common stock on September 30, 2005. The preferred stock was convertible into common stock on a one-for-one basis and had no expiration date.
