In accordance with the terms of a Trading Plan (SEC Rule 10b5-1 - Securities Exchange Act of 1934) established on December 17, 2007, A. William Stein converted 10,590 long-term incentive units into common limited partnership units ("Common Units") of Digital Realty

(1) Trust, L.P., a Maryland Limited Partnership (the "Operating Partnership"), and subsequently redeemed the 10,590 Common Units for 10,590 shares of the common stock of Digital Realty Trust, Inc. (the "Issuer"), all in accordance with the requirements of the Limited Partnership Agreement of the Operating Partnership.

Long-term incentive units are profits interest units in the Operating Partnership. Vested profits interest units may be converted into an equal number of Common Units in the Operating Partnership on a one-for-one basis at any time. Common Units are redeemable for cash (2) based on the fair market value of an equivalent number of shares of the Issuer's common stock, or, at the election of the Issuer, for an equal number of shares of the Issuer's common stock, subject to adjustment in the event of stock splits, stock dividends, issuance of stock rights, specified extraordinary distributions or similar events.

Since the date of Mr. Stein's last ownership report, he transferred 1,379 Long Term Incentive Units from his 10/27/2005 profits interest (5) units award to his former spouse pursuant to a domestic relations order. Mr. Stein no longer reports as beneficially owned any securities owned by his former spouse.
