- (2) This option becomes exercisable in increments of 33.3333%, 33.3333% and 33.3334% at such time that the closing sales price per common share is equal to or exceeds \$16.69, \$21.69 and \$26.69, respectively; provided that such market price targets are achieved by January 1, 2011. In any event, however, the option vests by January 1, 2013.
