- (1) Pro rata distribution to the managing members of ABS Partners IV L.L.C. (the "General Partner").  
 Includes shares acquired in pro rata distribution by the General Partner. Phillip A. Clough and Timothy T. Weglicki are managing members of the General Partner. Mr. Clough directly owns 11,769 shares. Mr. Weglicki directly owns 8,180 shares and indirectly owns 5,192 shares owned by The Timothy T. Weglicki Irrevocable Trust dated March 11, 1999 (the "Trust"), which shares Mr. Weglicki disclaims beneficial ownership of except to the extent of his pecuniary interest therein. The shares directly owned by Messrs. Clough and Weglicki include Restricted Stock Awards to each of them of 933 shares granted pursuant to the directors' compensation policy for non-employee directors of American Public Education, Inc. (the "Company"). Continued in Footnote 3.
- (2) Continued from Footnote 2. The Company's compensation committee annually grants each non-employee director an award of restricted common stock of the Company having a value of \$36,750 on the date of grant. The shares vest on the earlier of the one year anniversary of the date of grant and immediately prior to the 2009 annual meeting of stockholders.
- (3) The General Partner is an indirect beneficial owner of shares described in Footnote 2 and disclaims beneficial ownership of the shares except to the extent of its pecuniary interest therein. Mr. Clough disclaims beneficial ownership of the shares owned by Mr. Weglicki and the Trust. Mr. Weglicki disclaims beneficial ownership of the shares owned by Mr. Clough and is an indirect beneficial owner of the shares owned by the Trust for which he disclaims beneficial ownership except to the extent of his pecuniary interest therein.
