These shares represent a grant of 750,000 restricted stock units that vest as follows: fifty percent (375,000 shares) on the date of grant, (1) and fifty percent (375,000 shares) on December 31, 2010, so long as the reporting person is providing services to the Company on that date.

(2) As a result of the vesting of 375,000 restricted shares of common stock on the grant date, the reporting person surrendered 99,187 of such shares to the Company as payment for the withholding taxes due in connection with such vesting.
