- (1) On November 11, 2008, Mr. Dentinger received a grant of restricted stock units ("RSUs") covering 40,000 shares of KLA-Tencor common stock. On November 11, 2010, Mr. Dentinger vested in fifty percent (50%) of such RSUs.
- (2) Pursuant to the terms of the November 11, 2008 RSU grant, 9,045 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. The fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on such vesting date.
- (3) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.
