- (1) The Sale reported on this Form 4 was affected by a 10b5-1 trading plan adopted by the Reporting Person on February 22, 2011.  
Options granted to the Reporting Person under the 2001 Share Option Plan and are subject to a five-year vesting schedule. One quarter of the shares vested as of September 16, 2005. The remainder of the shares vested proportionally each month over the 48 months following September 16, 2005.
- (2) Options granted to the Reporting Person under the Issuer's 2001 Share Option Plan are subject to a four-year vesting schedule. One quarter of the option shares vested on September 16, 2003. The remaining option shares vested proportionally each month over the 36 months following September 16, 2003.
- (3) Options granted to the Reporting Person under the Issuer's 2001 Share Option Plan are subject to a five-year vesting schedule. One fifth of the option shares vested on April 11, 2004. The remaining option shares vested proportionally each month over the 48 months following April 11, 2004.
